#### 1. Introduction

This policy statement sets out the arrangements for managing the access of providers to students at the college, for the purpose of giving them information about the provider's education or training offer. This complies with the college's legal obligations under Section 42B of the Education Act 1997.

#### 2. Student entitlement

All students in years 7-13 are entitled:

- o to find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point;
- to hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships – through options events, assemblies and group discussions and taster events;
- o to understand how to make applications for the full range of academic and technical courses.

From January 2023, in order to adhere to the updated provider access legislation (PAL), the school will provide at least four encounters with approved providers of apprenticeships and technical education for all students:

- Two encounters for students during Yr 8 & 9 (one per year) that are mandatory for all to attend
- Two encounters for students during Yr 10 & 11 (one per year) that are mandatory for all to attend

A provider, to whom access is given, must deliver an encounter that includes the following:

- Information about the provider and the approved technical education qualifications or apprenticeships that the provider offers
- Information about the careers to which those technical education qualifications or apprenticeships might lead
- A description of what learning or training with the provider is like
- Responses to questions from the pupils about the provider or approved technical education qualifications and apprenticeships.
